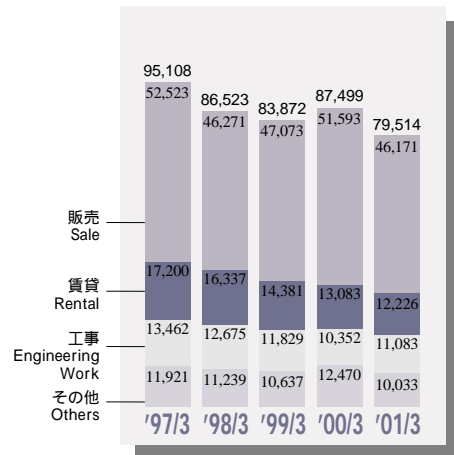

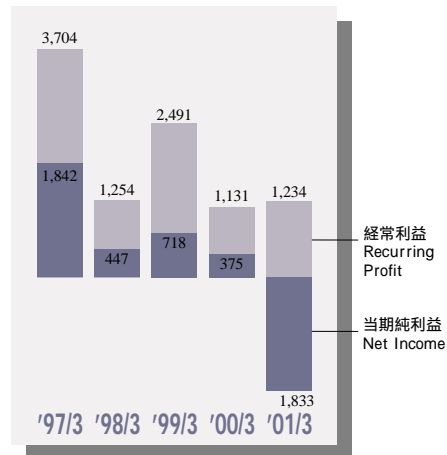

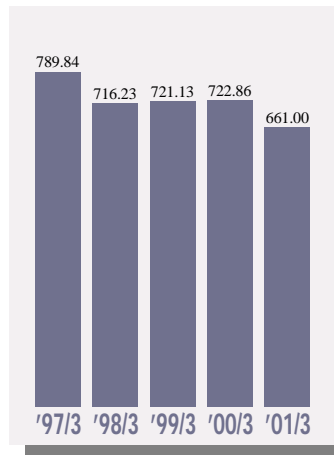
取引形態別売上高 (百万円)

(¥ Millions)



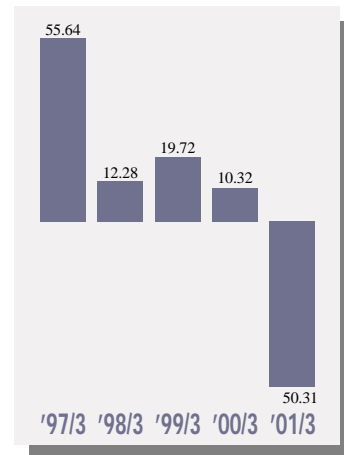

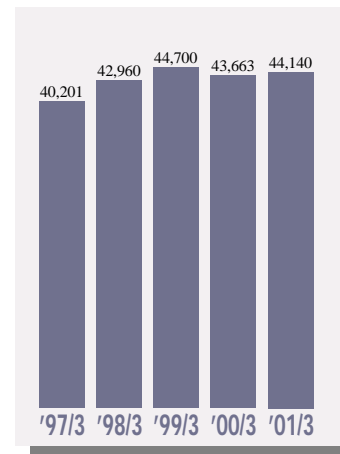

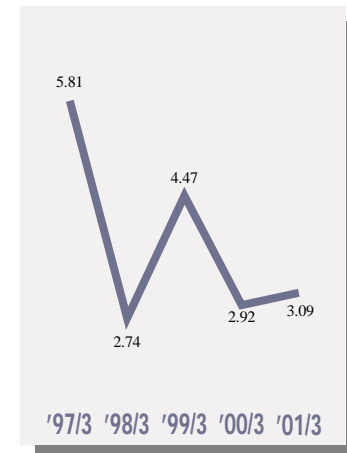
